#### **Memo Describes Code Changes**

Legislation approved by delegates at the Grand Lodge Annual Communication in October has resulted in several changes in the Code

#### MWB George O. Braatz, P.G.M. Accepts New Position

Most Worshipful Brother George O. Braatz, Grand Master 1987-1988, was selected recently as the new Executive Secretary of the Masonic Service Association of North America by MSA's Executive Commission. He succeeds MWB Richard E. Fletcher, a Past Grand Master from Vermont, who is retiring after 24 years of service as the chief operating officer of MSA.

The MSA was formed in 1919 and is headquartered in Silver Spring, MD. It provides educational material, statistical reports, disaster relief, and administers a hospital visitation program across North America.

MWB Braatz emerged as the Board's designee over approximately 20 other candidates. This is a great responsibility for the former Grand Secretary of the G.L. of Ohio. Ohio Masons are proud of his being selected to this important role and we all wish him the greatest success.

#### **Grand Lodge Mileage & Per Diem Checks**

Mileage and per diem checks were recently mailed to the address of the Lodge Secretary. If you did not receive a check it could have been for two different reasons. If the Grand Lodge Office did not receive your annual per capita payment before the deadline of August 31st (Grand Lodge Code, Chapter 7 - Annual Return) then no check was mailed.

Or, while attending the annual Grand Lodge Communication, if the Lodge's representative did not drop his Friday or his Saturday pay slip into one of the collection boxes, the Lodge will not receive payment. Announcements are made during the Communication reminding the delegates how important it is for them to deposit these slips, one on Friday and one on Saturday, into one of the red boxes located at the main entrances to the Lodge room. These pay slips are the only physical evidence we have that the Lodge was truly represented in the session.

Every year we receive calls from Lodges who were present but didn't deposit their pay slips. We can't issue a check without this slip. This is so important to the Lodge in receiving your expense check.

Please save this information and remind your Lodge representative attending next year's Communication to please deposit his pay slips in the collection box. (Note: he receives his slips at the time he registers.)

#### **Lodge Consolidations**

Effective November 7, 2011, Sinking Spring Lodge #365 merged with Highland Lodge #38, with Highland Lodge being the surviving Lodge.

Effective November 18, 2011, Mentor Lodge #772 merged with Temple Lodge #28, with Temple Lodge being the surviving Lodge.

We presently have 505 Lodges in Ohio.

#### The List of Lodges—Masonic

Approximately every four years Grand Lodge would purchase "The List of Lodges—Masonic" book for each Lodge. The information in this book rarely changes that significantly and the price has increased to \$15.30 per book.

Grand Lodge will not be providing every Ohio Lodge with a copy of this book. However, we will keep a nominal number of copies in stock and offer the book at a subsidized cost until the supply runs out. Note: the 2012 edition is not available until April.

# **Endowed Membership Fund Distribution**

At the Annual Communication of Grand Lodge, included in the Grand Lodge Investment Committee's Report was the amount of distribution for endowed members. (\$16.00 & \$21.00)

The Grand Secretary's Office has received numerous calls regarding the distribution amount received. Why is the amount so low?

The simple answer is reflected in the state of today's general economy. How are you personally doing on your investments? How much is the Lodge earning on the return from its investments? Pretty bleak. The yield from the Endowed Membership Fund is no different and we have professionals managing the investments!

# A Word From The Grand Treasurer About the Grand Lodge Endowed Membership Program

The Grand Lodge Endowed Membership Program is established by the Grand Lodge of Ohio Code, Sec. 29.06 (d) Membership and Memorial Endowment Fund. The Code states that "The income from such fund shall be distributed annually to the endowed Lodges..." As of August 31, 2011 the number of endowed memberships totaled 10,400 with an endowed principle balance of \$6,922,600. Since these funds are invested in a variety of investment vehicles including cash and cash equivalents (money market investments), the income from the investments is subject to the same market conditions that affect both personal and institutional investments.

Payout is limited to 5% of a 13-quarter average of the endowed fund's balance. During the Grand Lodge Masonic Year the income received from the Endowed Membership principle funds represented **2.6%** of the fund balance.

During the recent 202<sup>nd</sup> Annual Communication of the Grand Lodge of Ohio, legislation was adopted to amend the rules concerning the Endowed Membership Program to permit the Investment Committee to distribute in addition to the investment income, investment gains in excess of the Endowed Membership principle balance.

In addition, consideration is being given to determining the distribution amounts to endowed Lodges prior to the annual Grand Lodge Communication and forwarding this information to the individual Lodges for budgeting purposes. My Brethren, do not lose sight of the importance of the Endowed Membership Program to the Masonic fraternity and more importantly, to your Lodge.
