# **<u>Does Your Lodge Have a Fire Extinguisher?</u>**

It is a wise suggestion that every Lodge have several fire extinguishers capable of dowsing a fire in the kitchen area, social room, and the Lodge meeting room. The extinguishers should be inspected annually. Not only is this a sound preventive measure but it could help in a reduced insurance premium.

While we're at it, it is also a good idea to consider having some of your Brethren trained in Red Cross first aid, CPR, and AED. Hopefully, this training will never be needed, but we never know.

The Have & Have Not Committee is a repository for gently-used surplus Lodge paraphernalia. As Lodges merge, the surviving Lodge is often left with duplicate sets of robes, officer's jewels and aprons, ballot boxes, etc. Rather than allowing these items to gather dust, please consider donating surplus inventory to the Have & Have Not Committee. #### **ALL Lodges MUST file a 990 Form!**

As a reminder, all Ohio Lodges must annually file an IRS Form 990 in order to maintain our federal tax exemption status.

Lodges with annual gross receipts of \$25,000 or less file the Form 990-N (epostcard). Lodges with annual gross receipts less than \$500,000 and total assets less than \$1.25 mil can file either Form 990-EZ or Form 990. Lodges with gross receipts > than \$500k or total assets > \$1.25 mil must file Form 990.

Please note, use the physical address of the Lodge building and NOT the Secretary's address.

#### All Lodges to be on MORI by July 31st !!

If you are one of the handful of Lodges still NOT using the MORI membership management system, you have until July 31, 2011 to

start using it. As of August 1, 2011 the manual, paper-based, "green sheets" will be discontinued.

If you ARE currently using MORI to manage your Lodge membership, then please do not send any "green sheets" to the Grand Lodge Office!

#### **Suggestion Regarding Endowed Members**

It is probably pretty typical each year at dues time that you simply send the Endowed Member his dues card with maybe the latest Lodge newsletter.

It should be of no surprise to anyone how market investments have performed over the past several years. The Grand Lodge Endowed investment fund is no exception. We all would like to see better performance and a return to the those days of high market yields. Then, our payouts for Endowed Members would be much higher.

While the intention for Endowed Memberships was to cover Grand Lodge per capita into perpetuity, the payout is probably not equal to most Lodge's annual dues.

As a suggestion, as you send your Endowed Members their annual dues card, have you thought about sending them a personal letter? The letter could summarize the financial situation your Lodge is in, i.e. rising costs and reduced revenue. Acknowledge the Endowed Member has given the Lodge a perpetual gift, but encourage him to consider a donation to assist the Lodge in meeting financial needs.

#### **Use of Rejected Petitioner Cards**

The Lodge rejected a petitioner by ballot, now, as Secretary, what do you do?

Note that a rejected petitioner may repetition the same Lodge without regard to any

waiting period or timeframe. However, no other Lodge can receive a petition from him for at least one year from the date of rejection

Upon rejecting a petitioner, the Lodge Secretary shall immediately report to the Grand Lodge the name, birthdate, address, date of rejection, along with the Lodge name, number and address.

You can get this rejected petitioner card (Form #29) free of charge from the Grand Lodge office. A thorough candidate investigation shouldn't be complete without a quick call to check the Grand Lodge's rejected petitioner file

### <u>Plural & Dual Members and 50-Year</u> Awards

A foreign jurisdiction awards their members who have served 50 years or more of continuous service in good standing a gold membership card and remits their dues for the rest of their life. If this member joins an Ohio Lodge as a dual member is he entitled to have his Ohio dues remitted automatically?

If an Ohio Lodge XYZ has a standing resolution to remit the dues of their 50 year and above members and such a member joins Ohio Lodge ABC as a plural member, should he expect his dues to be automatically remitted by his plural Lodge, Lodge ABC?

Similarly, if a 50-year member of Ohio Lodge XYZ last year joined four other Ohio Lodges as a plural member, should he expect to receive a 50-year pin and certificate in these other four Lodges?

These are all situations that have come into the Grand Lodge Office. In each case the answer is, "No".

For years of service, your membership is tied to the date you became a member of the Lodge, either your primary home Lodge or as a dual or plural Lodge member.

## REMEMBER: MORI Key is stored in a "Cookie"

This has been mentioned before, but for the benefit of new MORI users and as a reminder to you veterans, I am publishing this again.

In order to access the MORI Membership Management System, each user is assigned a key. Gayle generates this key and mails it to you. Keep this key stored in a safe and secure place because you will undoubtedly have to reenter it periodically.

The user's key is stored on your system as a "Cookie". Every now and then, when you perform a system clean-up, you will delete the Cookies. This purges your MORI key and will have to be reentered by you before being able to access the application.

#### **Approved Annual Return Binder**

One of the questions your inspecting DDGM will ask is, "Do you have an approved Annual Return Binder?" As a follow up question he should ask, "Do you have your Annual Returns securely stored within the binder?"

The Grand Lodge Office seems to have had a rash of calls requesting copies of the Lodge's Annual Return because, for whatever reason, they don't have them. Even with new Secretaries, the former Secretary should have turned over the binder containing the

Lodge's Annual Returns. This binder should be stored in some secure place in the Lodge building and not off site at someone's home.

### **Honoring Our Veteran Lodge Members**

It should be on every incoming Worshipful Master's calendar of events to hold a Lodge Awards Night during his term. Ideally, this event should be held as early in the Lodge's new year as possible.

I recently received a note from a senior member asking me to verify his eligibility for a veteran service award this year. I checked and replied that he was indeed eligible. I checked the records and saw that his Lodge had not yet ordered their service awards. I was then curious as to how many other Lodges hadn't yet ordered their awards. As of this date, we have approximately 130 Lodges that have not ordered their service awards which range from 25-year emblems to 75-year awards. Some Lodges have not ordered awards for over three years.

The Lodge's Awards Night should be one of the highlights of the year for the Lodge. It should be a great evening, well-planned and filled with fellowship. Our senior members look forward to achieving this milestone in their Masonic journey. It disappoints me, to say the least, when these veteran members are not recognized for their years of service, dedication and commitment to the Craft.

I hope your Lodge is not on this list.

## **Automatic External Defibrillator (AED) in Your Lodge or District?**

While at an open Lodge Installation, a member experienced a heart attack. Fortunately, there were two RNs present that stabilized him until local EMTs arrived and administered care using an AED.

As a result of this incident, RWB Coey launched a fundraiser to purchase an AED for use within the District. The device will be taken to each District event.

The 23rd District Association is encouraging every 23rd District Lodge to purchase a unit to keep in their Lodge.

The device will direct the operator, step by step via voice commands. It has a fail safe within that will not allow you to administer a charge to the victim if it senses a heartbeat.

This sounds like a great idea to promote throughout Ohio. As RWB Coey asks, "What is life and what does it mean to you?"
